## Albany Township-Road Tour-April 16, 2013

Discussion was had on 1.) Roads to gravel; 2.) Roads to cover with dust suppressant; 3.) Placement of weight limit signs.

## 1-Roads to gravel

251 Avenue, 365 Street, 245 Avenue, 248 Ave (north side of freeway), 235 Ave, 230 Ave, 360 Ave will be done with the exception of the area from 245 Ave to 235 Ave. This section will be done when the road construction is completed.

A motion to approve the above roads for gravel was made by Supervisor Nierenhausen, seconded by Supervisor Lehnen, motion carried, unanimously.

## 2-Dust Suppressant

All roads that will be newly graveled plus the section on 330 St that was graveled in 2012 will be covered with dust suppressant.

A motion to approve the above roads to be covered with dust suppressant was made by Supervisor Nierenhausen, seconded by Supervisor Lehnen, motion carried unanimously.

## 3-Road Signs

The following signs have been purchased and will need to be placed:

10-Weight 7 ton, 5 ton during weight restrictions

6-Weight 9 ton, 5 ton during weight restrictions.

The following roads will be signed.

County Road 156 and Sand Lake Road-7 ton ahead

- 1. Sand Lake Road past Kutzer's gravel pit-7 ton/5 ton
- 2. Fifth Lake and 330 St-7ton/5 ton (replace existing 7 ton sign)
- 3. County Road 54/Quaker Road-7ton/5 ton
- 4. Township limits/Quaker Road-7 ton/5 ton
- 5. 219 Ave/County Road 10-7 ton/5 ton
- 6. 360 St/ Hwy 238-7 ton/5 ton
- 7. 360 St/Cty Road 10-7 ton/5 ton
- 8. 350 St/Cty Road 10-7 ton/5 ton

A motion to install signs as stated above was made by Supervisor Lehnen, seconded by Supervisor Nierenhausen, motion carried, unanimously.

Remaining signs will be decided during the spring road tour.

A motion to adjourn was made by Supervisor Nierenhausen, seconded by Supervisor Lehnen, motion carried, unanimously. Meeting adjourned at 6:30 P.M.
